The Role of Coercion in Peacebuilding: Insights from Africa in an Interregional Perspective

This international research workshop is to create a space for exchange on the role of coercion in peacebuilding. Around 35 international researchers are invited to share and discuss insights from Africa in an interregional perspective. The Kofi Annan Peacekeeping Training Centre (KAIPTC), the Institute for Peace and Security Studies (IPSS) and the Peace Research Institute Frankfurt (PRIF) are welcoming you in Accra, Ghana, from 05 to 07 October 2022!

The 2.5-day program is organized in **thematic panels** allowing for an in-depth discussion of underlying research perspectives and ideas. The first panel brings together scholars who work on varied aspects of coercion in peacebuilding using different theoretical and methodological approaches and aims at conceptualizing coercion. The second and third panel take coercion into view by drawing from empiric case studies. The fourth panel focuses on regional organizations in peacebuilding, and the fifth panel is dedicated to non-traditional or new state actors in peacebuilding. The latter three panels analyse the approaches of these new or non-traditional actors in how they differ from interventions by traditional peacebuilding actors and, in particular, they discuss the role of coercion in interventions of these actors. All participants will provide short discussion papers prior to the workshop. Every panel will have a chair who guides the session. As we understand the collective aim to be an open exchange in order to define joint research strands, we will not allocate individual discussants but rather want to involve all participants in the discussion. In addition to the panels, a **World Café** in the beginning as well as a **roundtable** at the closing day will further facilitate dialogue.

After the workshop, the partner institutions develop a report on the main outcomes of the workshop. This report will be shared with key actors in peacebuilding.

Prof. Adekeye Adebajo is a Senior Research Fellow at the University of Pretoria's (UP) Centre for the Advancement of Scholarship (CAS) in South Africa. He was Director of the Institute for Pan-African Thought and Conversation (IPATC) at the University of Johannesburg (UJ) in South Africa for five years, and is the author of Boutros Boutros-Ghali: Afro-Arab Prophet, Pharaoh, and Pope (Jacana and Routledge, 2022).

Dr. Monalisa Adhikari works as Lecturer in International Politics at the University of Stirling. She is a Co-Investigator of the Peace and Conflict Resolution Evidence Platform (PeaceREP) project at the University of Edinburgh. Her research interests include peace processes, international interventions, and conflict management efforts by Asian states including, India, China and Japan.

Prof. Isaac Olawale Albert is Professor of African History, Peace and Conflict Studies at the Institute for Peace and Strategic Studies (IPSS) of the University of Ibadan and was pioneer Director of the Institute until 2018. He is a specialist in conflict analysis, peace process planning, peace education and monitoring and evaluation. His main academic interest is to develop peace studies programmes and produce Afrocentric publications. His latest publications include urban crisis and crisis management in Africa.

Prof. Kwesi Aning is Director Faculty of Academic Affairs & Research (FAAR) and the Kofi Annan International Peacekeeping Training Centre (KAIPTC), Ghana and Clinical Professor of Peacekeeping Practice at Kennesaw State University, Atlanta. In 2015, he was appointed by the UN Secretary General to serve as a member of his Advisory Group to the Peacebuilding Fund. He is presently the Visiting Claude Ake Chair at the Nordic Africa Institute and Uppsala University, Sweden. In 2021, he served as a senior consultant on the Independent Project Evaluation on Support to the Maldives on Counterterrorism, and in 2022 appointed as a UN Expert on evaluating the EU's Counter-terrorism interventions in Sri Lanka. From November 2022, he will serve on the World Food Programme Security Advisory Team. Research interests include peacekeeping economies, hybrid political orders, security sector reform, and stability operations.

Dr. Festus Kofi Aubyn is Regional Coordinator, Research and Capacity Building at the West Africa Network for Peacebuilding (WANEP). Before, he worked as Research Fellow at the Kofi Annan International Peacekeeping Training Centre (KAIPTC). As Senior Researcher and Lecturer, he focuses on conflict and security management, peacebuilding, peace operations, terrorism, violent extremism and election security.

Sophia Birchinger holds the position of a Researcher and is part of the Research Group "African Intervention Politics" at Peace Research Institute Frankfurt (PRIF). In this capacity, she works on the case study of The Gambia as part of the project "Local perceptions of regional interventions: AU and ECOWAS in Burkina Faso and The Gambia". Her research topics cover peacebuilding and the African Peace and Security Architecture (APSA). Currently, Sophia prepares her PhD project on perceptions of coercion in African regional interventions.

Dr. Emma Birikorang is the Deputy Director at the Faculty of Academic Affairs and Research of the Kofi Annan International Peacekeeping Training Centre (KAIPTC). She is currently undertaking research on African Peace and Security Mechanisms and ECOWAS/AU regional peacekeeping frameworks. She facilitates training modules on security sector governance, protection of civilians in armed conflict, preventing violent extremism, risk assessment and conflict vulnerability, and conflict-related sexual violence. Emma is Head of the editorial team for the KAIPTC academic publications. Her current research interests are gendered dimension of violent extremism and terrorism, democratic reversal in African countries, regional peace and security, maritime insecurity in West Africa and peacekeeping transitions.

Dr. Melanie Coni-Zimmer works as Senior Researcher at the Peace Research Institute Frankfurt. Her research interest includes the role of economic actors in conflict zones, conflict prevention and peacebuilding. Her current work focuses on civil society engagement with international economic organizations. Recently she published, among others, on security sector reform and gender as well as crisis prevention in German foreign policy. Since 2015 she is Member of the Advisory Board to the Federal Government for Civilian Crisis Prevention and Peacebuilding.

Major Saidi Mwachinalo Dosho currently doubles up as the Head of Curriculum Design and as an Applied Researcher at the International Peace Support Training Centre, Kenya. He holds a Master's Degree in Strategic Management and a Bachelor's Degree in Education from the University of Nairobi, Kenya. He previously worked at Kenya Military Academy and 77 Artillery Battalion as an Assistant Lecturer and Education Officer respectively. He served in United Nations' Mission in South Sudan (UNMISS) in 2011/2012. His focus in research is in the interphase of psychosocial characteristics and behavioural outcomes. Specifically, his research interest lies in exploring violent extremism and management measures.

Dr. Fiifi Edu-Afful is a Senior Research Fellow and the Deputy Program Head of the Peace Support Operations Programme at the Kofi Annan International Peacekeeping Training Centre (KAIPTC). He has nearly 10 years' experience authoring, teaching and facilitating on conflict, peace and security. Between 2013 and 2014, he served as an Advisory Team Member for the United Nations Office of Internal Oversight Services (OIOS) on the prevention of sexual exploitation and abuse in UN peacekeeping. He specializes in peacekeeping, internal military operations, violent extremism and sexual violence against men and boys in conflict.

Prof. Fana Gebresenbet Erda is an Associate Professor and currently the Interim Director of the Institute for Peace and Security Studies (IPSS), Addis Ababa University. Also, he is a Research Fellow at the Center for African Studies, University of the Free State, South Africa, and was a Southern Voices Scholar at the Wilson Center, Washington, DC, United States. Fana's primary research interest is on themes related to the politics of development, political economy, pastoral development/conflict, and migration.

Ruth Adwoa Frimpong is currently a Doctoral Candidate at the Kofi Annan International Peacekeeping Training Centre (KAIPTC). She also works with the Early Warning Directorate of the ECOWAS Commission under the Office of the Vice President on the thematic areas of terrorism and violent extremism in West Africa. Her research interests concern peacebuilding, peace support operations, human security, gender mainstreaming, and security sector governance. She currently serves as a youth advisor on the youth advisory board of the Dallaire Institute of Children, Peace and Security in Rwanda.

Dr. Birte Gippert works as a Senior Lecturer International Relations at the University of Liverpool. Her research focuses on global governance and international post-conflict peacebuilding. She is interested in local agency in peacebuilding operations, particularly local legitimacy and resistance, democratisation and UN peacekeeping, EU security and defence policy and international police reform. She previously worked at the University of Reading, in the War Studies Department at King's College London, and as a researcher for the Kosovo Stability Initiative, Pristina.

Prof. Lise Morjé Howard is Professor of Government and Foreign Service at Georgetown University, and President of the Academic Council on the United Nations System (ACUNS). She also currently serves as Senior Fellow in Residence at the U.S. Institute of Peace (2022-23). She has written two award-winning books about different aspects of United Nations peacekeeping, both published by Cambridge University Press, as well as scholarly articles about civil war termination, the UN Security Council, and American foreign policy. She has held yearlong fellowships at Stanford University, Harvard University, and the University of Maryland.

Prof. Tony Karbo holds the position of Executive Director N'Zarama Center for Peacebuilding based in Abidjan, Cote d'Ivoire. Tony previously served as Associate Professor and Senior Program Officer at the University for Peace (Africa Program). He has more than 25 years of experience in the conflict resolution field, including working for the Carter Center, the Institute for Multi-Track Diplomacy (IMTD) in the United States, the South-North Centre for Peacebuilding (SNCPD), and the Institute of Peace, Leadership, and Governance (IPLG) at Africa University in Zimbabwe. He holds a Ph.D. in Conflict Analysis and Resolution from George Mason University in Virginia, USA.

Dr. Sabine Mannitz holds the position of Head of Research Department "Glocal Junctions" at the Peace Research Institute Frankfurt (PRIF) and is Member of PRIF's Executive Board. Her expertise and interest lie in anthropology of globalization, conflicts in migration societies, social identity, political socialisation, culture of remembrance/remembrance politics, armed forces in democracy as well as security sector reforms and local ownership. Since 2022 she is principal investigator at the Regional Research Center Transformations of Political Violence (TraCe).

Prof. Erin McCandless is an independent scholar and Policy Advisor, with affiliations as Research Associate in both the Politics Department at the University of Witwatersrand in South Africa and with the German Development Institute (DIE) in Bonn, Germany. A widely published scholar, she has nearly three decades of experience working on and in conflict affected settings. Her research is broadly focused on understanding the drivers of conflict, fragility and crisis, and how processes of transformative change and emancipatory peace are secured and sustain. Dr. McCandless consults widely with international and civil society organizations, and she is co-founder, former Chief Editor and current Virtual Collections Editor of the international, peer reviewed Journal of Peacebuilding and Development.

Prof. Bamlaku Tadesse Mengistu works as an Associate Professor at Addis Ababa University at the Institute for Peace and Security Studies (IPSS). He earned his PhD in Peace and Conflict Resolution from Haramaya University, Ethiopia. His research interest concerns the role of women in conflict, dynamics of inter-group conflicts with resource underpinnings and the role of climate change in intergroup conflicts in the pastoral ecosystem.

Prof. Louise Wiuff Moe works as Associate Professor of the Department of Social Sciences and Business at Roskilde University. She is also Principal Investigator of the research program Pastoralist Climate Change Resilience in Somaliland (PACCS) funded by the Ministry of Foreign Affairs of Denmark. Having regional expertise on Sub-Saharan Africa, she currently works within two main research areas: Interactions between climate change and dynamics of (in)security as well as pathways for environmental peacebuilding and climate resilient development, and international security governance.

Dr. Michael Sitawa works as a Senior Researcher at International Peace Support Training Centre (IPSTC) in the Peace and Security Research Department. He also is a Senior Lecturer and former Acting Head of Programme of Postgraduate Studies School leading the MA Programme in Crisis Response and Disaster Management at the National Defence University-Kenya. Sitawa holds a PhD in Sociology from Kenyatta University and has worked with the African Union Mission in Somalia on capacity building for Somalia's Interim government as well as Youth Leadership. He has also consulted for the National Council of Churches of Kenya assessing the conflict trends and the effect of the Peace Education Program. Also, he is a chief editor of Africa Amani Journal of IPSTC.

Prof. Tim Murithi is Head of Programme at the Institute for Justice and Reconciliation (IJR), based in Cape Town, and Extraordinary Professor of African Studies at the Centre for African and Gender Studies, University of the Free State, South Africa. He published extensively, among others, on the Ethics of Peacebuilding, the African Unions' peacebuilding and development policies, on International Criminal Tribunals and Transitional Justice. Also, he is the editor of the Routledge Handbook of Africa's International Relations.

Dr. Charles Nyuykonge is Mediation and Peace Building Specialist; and an International Consultant providing inclusive mediation support, facilitating dialogues, capacity building, and advisory and technical assistance on peacebuilding processes with regional organizations, UN agencies, Research and Policy Institutes and Universities in Africa. Charles is currently working with the African Development Bank as a Peace and Conflict Analyst for Ethiopia and the Horn of Africa.

Dr. Cyril N. Obi is Program Director for the African Peacebuilding Network (APN) and the Next Generation Social Sciences in Africa program (Next Gen) at the Social Sciences Research Council (SSRC), New York. He works and has published extensively on the role of China and India in Africa, the Niger Delta and politics of petro-violence, energy transition, African peacebuilding and African peace, security and development. He serves on the editorial boards of several journals, including, African and Asian Studies, African Conflict and Peacebuilding Review, African Security Review, Brazilian Journal of African Studies and African Journal of Democracy and Governance. Dr. Obi is a recipient of the 2020 Peace Distinguished Scholar Award of the Peace Section, International Studies Association (ISA).

Major General Francis Ofori is the Commandant of the Kofi Annan International Peacekeeping Training Centre (KAIPTC). He was commissioned into the Engineer Corps of the Ghana Army in August 1985. His foreign operational deployments include Commanding Officer of UNIFIL GHANBATT 67, Combat Engineer Operations Staff Officer UNIFIL HQ Operations, all in South Lebanon, Commanding Officer MONUC GHANBATT 9, DR Congo, Military Observer with UN Iraq Kuwait Observer Mission (UNIKOM) and Chief J2, UN/AU Mission in Darfur, Sudan.

Wadeisor Rukato was a Peace, Security and Development Fellow at the African Leadership Centre from 2018 - 2020. She holds an MA in Security, Leadership and Society from King's College London. She also holds an MA in China Studies, with a concentration in International Relations, from Peking University's Yenching Academy. In 2020, she published a book chapter titled "Student Movements and Autocracies in Africa". While in China, she co-founded an online platform called From Africa to China, which seeks to add a youth voice to the dynamic discourse on Africa-China relations. Her research interest includes the security dimensions of Africa-China relations; the role of youth in peace and security in Africa; LGBTQ+ activism and joy-making in Africa; and the effectiveness of experiential peace education programs in both pre-conflict and post-conflict environments.

Dr. Samantha Ruppel is head of the BMZ African-German Leadership Academy at the German Institute of Development and Sustainability (IDOS). Her working areas include partnership in peacebuilding and development cooperation, postcolonial theory, learning and training formats. She received her doctorate from the Goethe-University Frankfurt a.M. and worked as researcher until recently for Peace Research Institute Frankfurt (PRIF), where she is now an associated researcher. Since 2019, she is Co-Founder, consultant and partner at RESULT Research Consult, an organization consultancy. Her research expertise includes civil conflict management, peacebuilding, local peace processes, critical peace research, Africa, especially West and East Africa.

Prof. Yohannes Tekalign is an Assistant Professor in Peace and Security Studies at the Institute for Peace and Security Studies (IPSS) of Addis Ababa University. He holds a master's and a Ph.D.in Peace and Security Studies from Addis Ababa University. He has over a decade's experience in teaching and research at Ethiopia's higher education institutions and has also written about half a dozen journal articles and book chapters on regional peace, security and development.

Prof. Mandy Turner is Professor of Conflict, Peace and Humanitarian Affairs at the Humanitarian Conflict Response Institute, University of Manchester. Her research focuses on the political economy of development, conflict and peace; contentious politics and the impact of civil society activism on public perception and government policy; the politics of international intervention, decolonial approaches to knowledge production; and the Israel-Palestine conflict. Before joining the University of Manchester, she directed the Kenyon Institute, the British Academy international research centre in East Jerusalem.

Dr. Antonia Witt is Senior Researcher and Head of the Research Group "African Intervention Politics" at the Peace Research Institute Frankfurt (PRIF). She leads the project "Local perceptions of regional interventions: AU and ECOWAS in Burkina Faso and The Gambia" and is principal investigator in the project "African Non-Military Conflict Intervention Practices". Her research focuses on the African Union, African regional organizations (ECOWAS, SADC), the African Peace and Security Architecture (mediation, prevention), political crises and unconstitutional changes of government in Africa, as well as legitimacy and authority in international politics. Antonia is the author of Undoing Coups: The African Union and Post-coup Intervention in Madagascar (2020, Zed Books).

Prof. Jonas Wolff is Head of the Research Department "Intrastate Conflict" at the Peace Research Institute Frankfurt (PRIF) and Professor of Political Science with a focus on Transformation Studies and Latin America at Goethe University Frankfurt. His research focuses on democracy and the transformation of political orders, contentious politics, international democracy promotion, and Latin American politics. He is Governing Board member of the German-Colombian Peace Institute (Instituto CAPAZ) and Principal Investigator of the Regional Research Center Transformations of Political Violence (TraCe) as well as of the Research Initiative "ConTrust: Trust in Conflict – Political Life under Conditions of Uncertainty" (ConTrust).

Dr. Xinyu Yuan is a Postdoctoral Researcher in International Relations and Political Science at Geneva Graduate Institute (IHEID), where she earned her doctorate in 2022. She specializes in norm contestation and global order transformation, civil society, peacebuilding, and Chinese politics. She currently works on a research project investigating the practices of China, Japan and Russia in fragile and conflict-affected settings in Africa and Asia. The project is funded by the Swiss National Science Foundation and hosted by the Centre on Conflict, Development and Peacebuilding (CCDP) at IHEID.
